### **What is included in a IAPD report?**

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

### **Where did this information come from?**

<b>Broker Statement</b>	The original action that eventually led to Chapter-11 Bankruptcy was dispute with former partners in the business. Even though the jury found me "Not Guilty," they erroneously assigned a portion of the judgment and punitive damages to me along with those who were found liable. The judge affirmed the judgment as it was and assigned damages to me. The case went to the Court of Appeals, which had affirmed the judgment 2 to 1 (one of the judges wrote a dissent opinion and suggested to either dismiss judgment against me or retrial). Supreme Court chose not to review the case. In any case, this civil action was not related to securities investments in any way and resulted from a dispute with former partners in a company involved in engineering services business.
