**Allegations:** MARYLAND STATE RESIDENT STATES IN WRITING HER FA MISLED HER IN CONNECTION WITH THE PURCHASE OF VARIABLE ANNUITY IN 11/07. CUSTOMER STATES HER FA STATED SHE COULD NOT RECEIVE HER PREMIUM BACK BECAUSE SHE SIGNED THE APPLICATION. CUSTOMER STATES THE PREMIUM SHOULD BE REFUNDED BECAUSE INS. CO. STATED IT DID NOT HAVE A SIGNED APPLICATION. THE ANNUITY HAS DECLINED IN VALUE BY APPROXIMATELY \$6,733. THE CUSTOMER SIGNED THE APPLICATION, VARIABLE ANNUITY DISCLOSURE FORM AND INSURANCE COMPANY ANKNOWLEDGEMENT FORM. THE FORMS DISCLOSED THE ANNUITY WAS VARIABLE AND SUBJECT TO MARKET FLUCTUATION. ALSO, FA CONFIRMS HE MET WITH THE CUSTOMER THREE TIMES AND HE DISCUSSED THAT THE ANNUITY WOULD FLUCTUATE IN VALUE. FA FURTHER STATES CUSTOMER'S DAUGHTER WAS PRESENT DURING ONE OF THE MEETINGS AND CONFIRMS CUSTOMER UNDERSTOOD PRODUCT AND AUTHORIZED ITS PURCHASE. THE COMPLAINT IS DENIED.

THE CLIENT SIGNED A DISCLOSURE STATING THAT THE PRINCIPAL IS NOT GUARANTEED. THEREFORE ALL OF HER ALLEGATIONS ARE FALSE. THE CLIENT HAS NOT REALIZED ANY LOSSES AT THIS TIME AND AS OF 5/20/2008 THE ACCOUNT VALUE IS \$197,000. SEVERAL ATTEMPTS HAVE BEEN MADE TO CONTACT THE CLIENT AND SHE HAS NOT RESPONDED.
