I IMMEDIATELY ALERTED THE FA TO THIS AND WE THEN CALLED THE CLIENT TO SEE IF SHE WAS BACK IN TOWN. SHE WAS BACK IN TOWN AND SAID THAT SHE NEVER SENT US ANY REQUESTS ON WIRING OUT MONEY. WE THEN IMMEDIATELY ALERTED OUR COMPLIANCE AND BRANCH MANAGER OF THE SITUATION.

ABOUT A MONTH WENT BY AND THE UBS LEGAL DEPARTMENT CONTACTED ME AND THE BRANCH MGR FOR A CONFERENCE/HEARING CALL ON WHAT EXACTLY HAPPENED.

ANOTHER WEEK OR SO WENT BY AND I WAS THEN TERMINATED BECAUSE OF IT."
