IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

Broker Statement

CLAIMANTS, IN FINANCIAL DISTRESS BECAUSE THEIR BUSINESS WAS IN TROUBLE, WITHDREW (BEFORE AGE 59½) \$95,000 FROM THEIR IRA PREMATURELY IN ORDER TO COVER EXPENSES. THEIR CREDIT CARDS WERE MAXED OUT, AT LEAST 4 BANKS HAD DECLINED THEM LOANS, THEY HAD NO OTHER CASH AVAILABLE AND THEIR ONLY LIFE INSURANCE POLICY (THAT THEY STATED THEY WANTED TO PRESERVE) DID NOT HAVE SUFFICIENT FUNDS TO BORROW OR CASH OUT IN ORDER TO MEET THIS CASH NEED. CLAIMANTS NOW CLAIM THAT THEIR PREMATURE WITHDRAWAL CAUSED THEM "INVESTMENT LOSSES" OF \$72,200 WHEN IN FACT, THESE ALLEGED LOSSES AMOUNT TO MOSTLY WHAT THEY OWE FOR FEDERAL & STATE TAXES AS WELL AS THE 10% EARLY WITHDRAWAL PENALTY. BECAUSE THEY PROBABLY DO NOT HAVE THE FUNDS NECESSARY TO COVER THEIR TAX LIABILITIES, CLAIMANTS APPEAR TO HAVE FILED THIS FRIVOLOUS CLAIM AS A WAY TO INVOKE A SETTLEMENT IN ORDER TO MEET THEIR CASH NEEDS. SETTLEMENT WAS MADE BY INSURANCE CARRIER AS AN ECONOMIC ALTERNATIVE TO CONTINUING COSTLY LITIGATION.
