What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

Broker Statement

JOHN AND TANDY TAYLOR (PLAINTIFFS/LIEN JUDGMENT CREDITORS) WERE INTRODUCED TO BRODY LANDON (DEFENDANT/JUDGMENT DEBTOR) THROUGH DERRICK SMITH (CO-DEFENDANT AND CO-JUDGMENT DEBTOR), WHO WAS THE TAYLOR'S FINANCIAL ADVISOR AT THE TIME. THE TAYLORS MADE A PERSONAL LOAN TO MR. LANDON AND MR. LANDON FAILED TO REPAY THE LOAN IN ACCORDANCE WITH THE LOAN TERMS. THE TAYLORS SUED MR. LANDON AND ATTACHED MR. SMITH TO THE SUIT. THE COURT AWARDED JUDGMENT TO THE TAYLORS AND HELD MR. LANDON AND MR. SMITH JOINTLY AND SEVERALLY LIABLE, AND PLACED A LIEN ON THE CO-DEFENDANTS IN THE AMOUNT OF \$89,243.80 WITH INTEREST. RENEWAL OF JUDGMENT WAS FILED IN AMADAR SUPERIOR COURT IN JACKSON, CALIFORNIA, ON MAY 31, 2022. THE LIEN WAS RENEWED IN THE AMOUNT OF \$89,243.80 WITH ACCRUED INTEREST OF \$86,479.65.
