I DIDN'T REALIZE I HAD TO HAVE AN ATTORNEY INITIATE THE EXPUNGEMENT. I THOUGHT IT WOULD HAPPEN AUTOMATICALLY. SO WHEN I APPLIED TO VANGUARD, I THOUGHT MY RECORD WAS COMPLETELY CLEAN.
