**Regulator Statement**

On March 17, 2022, the Office of Financial Regulation (Office) entered a Final Order adopting the Stipulation and Consent Agreement in the matter of William Albert Boselli, Jr. (Boselli). Boselli neither admitted nor denied the allegations but consented to the entry of findings by the Office. The Office found that Boselli violated section 517.12(4), Florida Statutes, by rendering investment advice, from a location within Florida, without being registered by the Office. Boselli agreed to Cease and Desist from violations of Chapter 517, Florida Statutes, and the Administrative Rules adopted thereto, and to pay an administrative fine in the amount of \$12,500. The Office agreed to approve Boselli's application as an associated person (RA) with Strategic Wealth Partners Inc. effective March 17, 2022.



## Customer Dispute

**Broker Statement**

Plaintiff's all all very wealthy individuals with assets from 5 million to 20 million in net worth. Strategy used was to generate cash flow without having to sell their securities. I've been using this strategy of selling calls and puts for over 25 years with success. When the market crashed in mid-March due to a frozen bond market ( actually the US Treasury ran out of money when the banks had to cash in their treasuries to extend lines of credit to businesses shut down by govt. direction) I could not unwind the trades without taking losses. When I informed the plaintiffs they immediately closed their accounts and called a lawyer thereby locking in their losses.
