IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations: ATTORNEY STATES THAT INVESTMENTS WERE MADE BY IR PURSUANT TO THE INSTRUCTIONS OF ONLY ONE OF THE CO-TRUSTEES ON THE TRUST, BUT THAT AUTHORIZATION FROM BOTH TRUSTEE WAS REQUIRED. ATTORNEY STATES THAT IR WAS TOLD BY CO-TRUSTEE THAT THE WIRED FUNDS WERE TO REMAIN IN MONEY MARKET UNTIL IR RECEIVED WRITTEN DIRECTIONS FROM BOTH TRUSTEES. ATTORNEY FURTHER STATES THAT IR EXPLAINED HE RECEIVED ASSISTANCE FROM THE TRUSTEE'S MOTHER'S CPA ON WHAT TYPE OF INVESTMENTS TO MAKE. ATTORNEY IS REQUESTING THAT ALL INVESTMENTS BE REVERSED AND RETURNED TO MONEY MARKET AND CO-TRUSTEE SHOULD ALSO BE REIMBURSED FOR LEGAL FEES ESTIMATED AT \$1,000. POTENTIAL LOSSES EXCEED \$5,000.

THE IR STATED HE DISCUSSED INVESTING THE PROCEEDS FROM A REAL ESTATE SALE WITH THE CO-TRUSTEE PRIOR TO DISCUSSING THE INVESTMENTS WITH THE OTHER CO-TRUSTEE. THE IR STATED HE FOLLOWED THE SAME PROCEDURE FOR OBTAINING INVESTMENT INSTRUCTIONS AS HE HAD DONE IN THE PAST WITH THIS ACCOUNT. THE IR FURTHER STATED HE WAS UNAWARE THE TRUST DOCUMENT CALLED FOR WRITTEN INSTRUCTIONS AS THE IR HAD NEVER SEEN THE TRUST DOCUMENT. A REVIEW OF THE FIRM'S RECORDS INDICATES THAT THE ACCOUNT REFLECTED THE INFORMATION PROVIDED BY THE TRUSTEES IN THE LIVING TRUST ACCOUNT FORM. THE BONDS PURCHASED ALL HAD AN ESTATE FEATURE. FURTHERMORE, THE IR STATED HE HAD THE CO-TRUSTEE'S PERMISSION TO CONSULT THE CPA AS TO HER RECOMMENDATION TO PURCHASE TAX-FREE BONDS AS OPPOSED TO TAXABLE BONDS. THE IR ALSO STATED THE CPA STATED SHE COULD SEE NO BENEFIT TO PURCHASING TAX-FREE BONDS. THE IR INDICATED THAT THE CO-TRUSTEE TOLD THE IR THAT HE COULD CONTACT THE CPA, THEN THE OTHER CO-TRUSTEE, THEN MOVE FORWARD FROM THERE. IT APPEARS THE IR FOLLOWED THE PREVIOUSLY ESTABLISHED PROTOCOL FOR OBTAINING INVESTMENT INSTRUCTIONS FROM THESE TRUSTEES.
