**Regulator Statement**

On August 9, 2021, the Office of Financial Regulation (Office) entered a Final Order adopting the Stipulation and Consent Agreement in the matter of Sam Angelo Curmaci (Curmaci). Curmaci neither admitted nor denied the finding but consented to the entry of the finding by the Office. The Office found that Curmaci violated section 517.12(4), Florida Statutes, by rendering investment advice, from a location within Florida, without being registered by the Office. Curmaci agreed to Cease and Desist from violations of Chapter 517, Florida Statutes, and the Office's rules promulgated thereunder, and to pay an administrative fine in the amount of \$26,000. The Office agreed to approve Curmaci's application as an associated person (RA) with Leigh Baldwin & Co., LLC effective August 9, 2021.
