Broker Statement

The client unsuccessfully raised their claims before a FINRA arbitration panel, in an action against J.P. Morgan Securities LLC ("JP Morgan"). On July 2, 2024, the FINRA panel granted JP Morgan's motion to dismiss, relying on several, independently sufficient grounds for dismissing the client's claims. Notably, the client pursued substantially similar claims in federal court against another JP Morgan entity, and the court dismissed all of the client's claims with prejudice, concluding that JP Morgan was entitled to judgment as a matter of law. Two different judges-the magistrate judge and the district court judge-reached the same conclusion. In addition, in its September 27, 2024 memorandum and order, the federal court repeatedly observed that plaintiffs had "mischaracterize[d] the record," used language that was "misleading," and made assertions that were "not supported by the evidence cited" and "simply not true." JP Morgan has consistently denied any and all claims of wrongdoing, and ultimately, the FINRA panel and the federal court agreed with JP Morgan's position.
