THE FIRM'S REVIEW FOUND THE CLIENT'S INVESTMENTS WERE BASED ON AN ASSET ALLOCATION MODEL. THE CLIENT STATED SHE UNDERSTOOD HER INVESTMENTS WERE LONG-TERM. SHE DID NOT COMMUNICATE TO ME THAT HER GOAL HAD CHANGED TO CAPITAL PRESERVATION. HOWEVER, IN A MEETING IN JANUARY 2001, I RECOMMENDED RE-BALANCING HER IRA, WHICH WAS SUBSEQUENTLY IMPLEMENTED. THE CLIENT WAS REIMBURSED \$547.31 FOR LOST EARNINGS DUE TO A DELAYED TRANSACTION HANDLED BY ANOTHER REGISTERED REPRESENTATIVE. ALSO, IN THE INTEREST OF GOOD CLIENT RELATIONS THE \$1486.76 CONTINGENT DEFERRED SALES CHARGE ASSESSED TO THE IRA WAS REIMBURSED.
