**Broker Statement**

The firm found that Mr. Ruediger was not made aware by the client, or their attorney, at the time the retirement plan was established that it was subject to Affiliated Service Group IRS requirements. Upon notification of the requirement, one year after the plan had been established, multiple requests to the client's attorney for assistance went unanswered. Additionally, the client acknowledged that Mr. Ruediger was not acting as a fiduciary with respect to the retirement plan. The firm denied the client complaint.
