What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Employing firm when activities occurred which led to the complaint: MONEY CONCEPTS CAPITAL CORP.

Allegations: Clients opened an variable annuity with the Guaranteed Withdrawal Benefit VIII Rider.. At the time of purchase, client allege Pallo assured them the annuities with the rider were RMD friendly and would not stop the rider. They learned in June 2017 that the benefit had stopped when the RMD withdrawals were made. They are requesting the contract stay in force. Pallo admits that he understood that RMD were permitted and would not effect the rider. Therefore, PacLife agreed to add the rider if Money Concepts reimburses the @ \$9,300 RMD into the account. Money Concepts has agree to reimburse for the error.
