### What is included in a IAPD report?

In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

### Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and

## Disclosure Summary

**Allegations:** STATE OF SOUTH DAKOTA SECURITIES DIVISION RELAYED IN WRITING TO FIRM A VERBAL COMPLAINT RECEIVED FROM CLIENT. CLIENT STATED TO THE REGULATOR THAT SHE PURCHASED A VAN KAMPEN UIT IN JANUARY 2002. CLIENT CLAIMED THAT IN JULY 2002, SHE WANTED TO SELL THE UIT AND THAT THE IR TOLD HER THERE WOULD BE A \$200 LOSS. CLIENT CLAIMED AFTER SELLING THE INVESTMENT, SHE FOUND OUT THAT THERE WAS ACTUALLY A \$9,000 LOSS. CLIENT STATES THAT WHEN SHE CONTACTED THE IR, THE IR ADMITTED THE MISTAKE AND OFFERED TO PAY HER THE \$9,000, BUT THEN RENEGED ON THE OFFER.

IR STATED THAT HE DID NOT RECALL TELLING CLIENT THAT THERE WOULD BE A \$200 LOSS ASSOCIATED WITH THE SALE. IR FURTHER STATED THAT THE CLIENT DID NOT CONTACT IR UNTIL APPROXIMATELY EIGHT MONTHS AFTER THE SALE TO INFORM IR OF CLIENT'S CONCERNS ABOUT THE LOSS.
