IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

### What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

### Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

**Allegations:** The client states the financial advisor explained that the client could sell bond funds in her accounts for a loss to offset income for her 2022 taxes. The client alleges the bond funds were sold without her authorization and she discovered, when filing her taxes, that the loss would offset capital gains - not income. Additionally, the client alleges the financial advisor subsequently recommended the purchase a New York Life Annuity and that this recommendation was made to generate commissions. Further, the client alleges the financial advisor had a duty to act in her best interests and he did not.
