IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

FIRM AND REGISTRANT DENIED ALL ALLEGATIONS AND DAMAGES. NO EVIDENCE OF REALIZED LOSSES COULD BE ATTRIBUTED TO THE REGISTRANT OR MONEY MANAGER IN QUESTION. THE COMPLAINT WAS DENIED IN JULY 2012. IN SEPTEMBER 2012, THE FIRM RECEIVED NOTICE OF SIMPLIFIED ARBITRATION SEEKING \$23,000 IN DAMAGES. REGISTRANT DENIES ALL ALLEGATIONS AND WILL DEFEND THE TRANSACTIONS. WITHOUT ADMITTING OR DENYING THE ALLEGATIONS, THE PARTIES SETTLED THE MATTER TO AVOID FURTHER TIME SPENT AND COSTS ASSOCIATED WITH THIS DISPUTE.
