IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations: AMONG OTHER THINGS, THE COMPLAINT ALLEGED THAT ON APRIL 28, 2005, BOTH FIC REGISTERED REPRESENTATIVE [OTHER FIRM EMPLOYEE] AND I DID NOT ADVISE [CUSTOMER] THAT HER PUTNAM IRA ACCOUNT WAS TRANSFERRED TO A NON-IRA ANNUITY ACCOUNT AND THAT THE TRANSFER WOULD TRIGGER A TAX CONSEQUENCE. IN ADDITION, THE COMPLAINT ALSO ALLEGED THAT WE DID NOT ADVISE [CUSTOMER] THAT THE SYSTEMATIC WITHDRAWALS SHE WAS TAKING FROM HER MUTUAL FUND ACCOUNT WOULD DEplete THE PRINCIPAL.

Broker Statement

AFTER RECEIVING THE COMPLAINT (WHICH WAS ALSO FILED WITH THE NASD), THE CLIENTS SENT IN A LETTER WITHDRAWING THEIR COMPLAINT. HOWEVER, AFTER INVESTIGATING THE ALLEGATIONS SET FORTH IN THE COMPLAINT, FIC CONCLUDED THAT WE WERE UNAWARE THAT THE CLIENT'S PUTNAM ACCOUNT WAS IN FACT AN IRA ACCOUNT AT THE TIME WE MADE THE RECOMMENDATION TO TRANSFER IT INTO THE CLIENT'S EXISTING VARIABLE ANNUITY. THUS, FIC RESCINDED THE TRANSACTION. FIC ALSO CONCLUDED THAT THE CLIENT HAD EXPERIENCE WITH SYSTEMATIC WITHDRAWALS AND THUS WAS AWARE THAT THE WITHDRAWALS FROM HER MUTUAL FUND ACCOUNT WOULD DEplete THE PRINCIPAL.
