What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

[CUSTOMER] HAS BEEN A CLIENT OF MINE FOR OVER FOUR YEARS. I HAD EXTENSIVE INTERACTION WITH HER FACE TO FACE AND AT LENGTH ON THE PHONE. AT ALL TIMES SHE FULLY UNDERSTOOD OUR CONVERSATIONS AND UNDERSTOOD INVESTMENTS. CLIENT BOUGHT THE ROCHESTER MUNICIPAL BOND FUND, MADE ONE ADDITION OVER THE TIME PERIOD. CLIENT SIGNED ALL CHASE REQUIRED DOCUMENTATION AFTER REVIEWING THE FORMS. IN MAY 2009, CLIENT GAVE ME THE VERBAL INSTRUCTIONS TO SELL THE FUND AND REINVEST THE PROCEEDS. SOMETIME AFTER THE TRANSACTION, CLIENT BECAME VERY AGITATED AND REFUSED TO CO-OPERATE WITH ME OR CHASE INVESTMENT SERVICES CORP. ("CISC"). SHE WROTE A LETTER CLAIMING SHE NEVER AUTHORIZED THE PURCHASE OF THE ROCHESTER FUND. SHE ORIGINALLY BOUGHT THE FUND IN 2006, RECEIVED OVER THREE YEARS OF MONTHLY STATEMENTS AND NEVER HAD A PROBLEM UNTIL 2009. CISC COMPLIANCE REVIEWED HER TRANSACTIONS AND FOUND NO WRONGDOING. HER REQUEST TO REVERSE THESE TRANSACTIONS AND RETURN HER PRINCIPAL WAS DENIED. HOWEVER, BECAUSE OF HER CONFUSION, CISC, REINSTATED HER INTO THE ROCHESTER FUND RESULTING IN A LOSS TO THE FIRM. IT HAS COME TO THE ATTENTION OF CISC THAT THE CLIENTS HEALTH AND BEHAVIOR HAS RESULTED IN A COURT APPOINTED LEGAL GUARDIAN. AS OF NOVEMBER 2009 ALL OF



THE CLIENT'S BANK AND BROKERAGE ACCOUNTS HAVE BEEN
RESTRICTED.
