IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

[CUSTOMER'S] ALLEGATIONS STATE THAT HE SHOULD HAVE BEEN ALLOWED TO PARTICIPATE IN THE INITIAL PUBLIC OFFERING OF GENENTECH INC. ON JULY 14, 1999, [CUSTOMER] CALLED ME TO PARTICIPATE IN THE DIRECTED SHARE PROGRAM FOR GENENTECH AS A FORMER SHAREHOLDER OF THIS RECENTLY ACQUIRED COMPANY. BECAUSE HE WAS A REGISTERED REPRESENTATIVE AT ANOTHER BROKERAGE FIRM, WE DECIDED TO DECLINE HIS OFFER TO PURCHASE UNDER NYSE RULE 407 AND THE NASD FREERIDING AND WITHHOLDING POLICY. [CUSTOMER] BELIEVED THAT HE WAS EXEMPT FROM THESE POLICIES AND SUBSEQUENTLY OBTAINED THE 407 LETTER FROM HIS FIRM AND AN EXEMPTION LETTER FROM THE NASD GENERAL COUNCIL. THIS INFORMATION WAS PROVIDED TO SCHWAB AFTER THE EFFECTIVE DATE OF THE INITIAL PUBLIC OFFERING AND [CUSTOMER] WAS UNABLE TO OBTAIN SHARES.
