IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement

I MOVED IN 2002 AND, BECAUSE THE STATE OF INDIANA ALLEGED THAT IT WAS NOT NOTIFIED OF MY NEW ADDRESS WITH IN 30 DAYS, THE INDIANA DEPT. OF INSURANCE IMPOSED A \$100 FINE ON MY LICENSE RENEWAL APPLICATION. I DID NOT REALIZE THAT THIS MATTER NEEDED TO BE DISCLOSED TO WISCONSIN. WHEN WISCONSIN LEARNED OF THE \$100 FINE, IT DENIED MY INSURANCE LICENSE FOR 31 DAYS. THIS ENTIRE CHAIN OF EVENTS BEGAN BECAUSE I MOVED AND INDIANA DID NOT RECEIVE NOTICE WITHIN 30 DAYS.
