IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

IT IS UNDERSTOOD THE POLICY PROCURED THROUGH THE IR WAS A COVA SINGLE PREMIUM VARIABLE LIFE POLICY (#550-1923) THAT WAS PURCHASED IN 2000. THE IR HAS INDICATED THAT, AT THE TIME OF PURCHASE, THE CLIENT INFORMED HIM INCOME WAS NOT NEEDED AND SHE DID NOT ANTICIPATE SPENDING ANY OF THE FUNDS. THE IR HAS FURTHER INDICATED HE SUGGESTED THE POLICY AS A MEANS TO INCREASE THE INHERITANCE THE CLIENT'S CHILDREN WOULD RECEIVE WITHOUT INCURRING TAX CONSEQUENCES. ACCORDING TO THE IR, THE CLIENT'S CHILDREN BEGAN QUESTIONING HER ACCOUNTS WITH HIM IN 2003. HE HAS INDICATED, AT THAT TIME, HE WAS INFORMED THE CLIENT DID NOT WANT INSURANCE AND HER OBJECTIVES HAD CHANGED. THE IR HAS STATED, WITH THE ENCOURAGEMENT OF THE CLIENT'S CHILDREN, THE POLICY WAS SURRENDERED IN JULY 2003. OUR RECORDS REFLECT AN APPLICATION WAS COMPLETED AT THE TIME OF THE PURCHASE; THEREFORE, IT WOULD APPEAR THE CLIENT, IN FACT, AWARE SHE WAS PURCHASING INSURANCE. THE IR HAS STATED, HE WAS NOT AWARE OF THE CLIENT OWNING ANY ADDITIONAL INSURANCE POLICIES; HOWEVER, HE UNDERSTOOD SHE DID OWN FIXED ANNUITIES. FURTHERMORE, WE WERE UNABLE TO LOCATE ANY OTHER POLICIES REGISTERED IN THE CLIENT'S NAME WITH COVA (WHICH IS NOW METLIFE). AS SUCH, IT WOULD APPEAR THE ADDITIONAL POLICY NUMBERS REFERENCED IN THE CLIENT'S CORRESPONDENCE (568-0532-1-8 AND 550-1915) ARE NOT PLACED WITH METLIFE. AT THIS TIME, WE ARE RESPECTFULLY DENYING THE CLIENT'S REQUEST FOR COMPENSATION IN THIS MATTER. ANY ADDITIONAL INFORMATION THE CLIENT WOULD LIKE TO PROVIDE REGARDING THE POLICIES IN QUESTION CAN BE SUBMITTED FOR REVIEW AFTER WHICH IT WILL BE DETERMINED IF FURTHER ACTION BY THE FIRM IS WARRANTED.
