**Allegations:** CLIENT STATES SHE CONTACTED IR, JOE BRITTINGHAM, FOR ADVICE ON INVESTING \$80,000. THE IR FIRST SUGGESTED A COMBINATION OF LORD ABBETT BOND FUND AND INVESTMENT CO. OF AMERICA (ICA), HOWEVER, ULTIMATELY RECOMMENDED ALL BE PLACED IN ICA. THE CLIENT CLAIMS THE IR INDICATED THIS WAS A GOOD, SAFE, CONSERVATIVE FUND THAT HAD ONLY BEEN DOWN TWICE WITH A NEGATIVE TOTAL RETURN OF -6% OVER THE LAST 60 YEARS. CLIENT STATES WHEN THE FUND BEGAN TO DROP IN VALUE SHE CONTACTED THE IR ABOUT MOVING THE FUNDS TO A BOND FUND WITH AMERICAN FUNDS; CLIENT CLAIMS IR REFUSED TO PROVIDE HER WITH OPTIONS OR DISCUSS MOVING THE FUNDS. FINALLY ALL FUNDS WERE PLACED IN MONEY MARKET. CLIENT STATES SHE THEN SPOKE TO ANOTHER IR WITH EDJ WHO PROVIDED HER WITH SEVERAL OPTIONS AVAILABLE WITH AMERICAN FUNDS AND, SHE BELIEVES, HAD THESE OPTIONS BEEN PROVIDED SHE WOULD NOT BE DOWN APPROX. \$15,000. CLIENT STATED THE IR, JOE BRITTINGHAM, WAS RUDE, ARROGANT AND INCOMPTETENT TO ADVISE INVESTORS. CLAIM EXCEEDS \$5,000

IR STATED HE REVIEWED THE CLIENT'S OBJECTIVES AND DISCUSSED VARIOUS INVESTMENT OPTIONS. IR STATED THE CLIENT CONTINUED TO REQUEST AN INVESTMENT WHICH WOULD PROVIDE AN EQUITY TYPE OF RETURN AND IR SUGGESTED PLACING ALL IN THE ICA FUND. IR STATED HE DID NOT INFORM THE CLIENT THE FUND WAS DOWN ONLY 6% TWICE IN THE LAST 60 YEARS BUT INDICATED THERE WAS NO GUARANTEE THE FUND WOULD CONTINUE TO AVERAGE 13.5% RETURN AS IT HAD OVER ITS LIFETIME. IR STATED THE CLIENT WAS INFORMED A BREAKPOINT COULD BE REACHED, HOWEVER, THE CLIENT REQUESTED "B" SHARES BE PURCHASED. CLIENT SIGNED BUY ACKNOWLEDGMENT LETTER ON 5/3/01. IR STATED HE AT NO TIME PROVIDED A GUARANTEE AS TO THE PERFORMANCE OF THE FUND. PROSPECTUS WAS PROVIDED AT THE TIME OF PURCHASE. IR STATED HE REVIEWED THE INVESTMENTS AT THE TIME OF THE 9/11/01 ATTACKS AND ADVISED CLIENT HE DID NOT BELIEVE ATTEMPTING TO TIME THE MARKET WAS IN HER BEST INTEREST. CLIENT EXCHANGED HER ICA FUND TO THE CASH MANAGEMENT FUND ON 9/21/01. LOSSES APPEAR TO BE THE RESULT OF MARKET FLUCTUATION. CLAIM DENIED.
