What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

IN FEBRUARY/MARCH OF 2008 THE CLIENT AGREED TO PURCHASE 10 MUNICIPAL BONDS AT \$45,000 FACE VALUE EACH. SOMETIME IN APRIL THE CLIENT EXPRESSED CONCERN AS TO THE MATURITY DATES OF THE BONDS THEN IN JUNE DECIDED HE WANTED 17 - 20 BONDS TOTALING \$450,000. WE PROMPTLY NOTIFIED THE BRANCH MANAGER WHICH LED TO SEVERAL MEETINGS BETWEEN THE BRANCH MANAGER AND THE CLIENT. SUBSEQUENT CONVERSATIONS LED TO THE LIQUIDATION OF SOME OF THE BONDS AND REPURCHASE OF SHORTER MATURITY BONDS. IN THE SPRING HE DECIDED HE DID NOT WANT THE REMAINING BONDS FROM THE ORIGINAL PURCHASE DATE AND WANTED HIS MONEY BACK ON THESE BONDS. (THE LOSS AT THIS TIME WAS APPROX \$9400).

IN JUNE THE BRANCH MANAGER BEGAN REQUESTING WE SUBMIT THE BONDS IN QUESTION FOR BIDS WHICH LASTED THROUGH OCTOBER WHEN THE BONDS WERE MOVED TO THE BRANCH ERROR ACCOUNT AND THE CLIENTS ACCOUNT CREDITED FOR THE ORIGINAL PURCHASE PRICE. FROM THE TIME THE BRANCH MANAGER BEGAN REQUESTING BIDS AND THE TIME HE INSTRUCTED THE OPERATIONS MANAGER TO MOVE THE BONDS TO THE BRANCH ERROR ACCOUNT WITH SUBSEQUENT A CREDIT TO THE CLIENT'S ACCOUNT, THE PORTFOLIO OF BONDS DETERIORATED ANOTHER \$20,000+/- FOR A TOTAL LOSS OF \$30,000.
