What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement DENIED BY FIRM. THE FA RECALLS THAT WHEN HE MET WITH THE CLIENTS, THEY TOLD HIM THAT THEY WERE FAMILIAR WITH ANNUITIES AND WANTED TO PURCHASE VARIABLE ANNUITIES WITH SPECIFIC RIDERS



AND FEATURES. THE FA RECALLS REVIEWING WITH THEM ALL OF THE INTERNAL COSTS FOR THESE FEATURES AND RIDERS AND REFERRING TO THE ANNUITY PROSPECTUS TO SHOW THEM THE FEES THAT WOULD BE ASSESSED. THE FA ALSO RECALLS PROVIDING THE CLIENTS WITH A PROSPECTUS, WHICH DISCLOSED ALL OF THE FEES THAT THE ANNUITY COMPANY CHARGES FOR THE ANNUITY. THE FA ALSO RECALLS RECOMMENDING THAT THEY INVEST IN A MUTUAL FUND PORTFOLIO INSTEAD, BECAUSE OF THE LOWER INTERNAL EXPENSES. HOWEVER, THE FA RECALLS THAT THE CLIENTS STATED THAT THE FEATURES AND RIDERS THAT THEY WERE PURCHASING WITH THE ANNUITIES WERE MORE IMPORTANT TO THEM THAN THE COST OF THE ANNUITIES. THE TOTAL PREMIUM PAID FOR ALL THREE ANNUITIES WAS \$633,722.42. THE CLIENTS HAVE WITHDRAWN \$157,121.60 FROM THE ANNUITIES AND THE TOTAL CURRENT MARKET VALUE OF THE ANNUITIES IS \$641,303.08.
