I MET WITH CUSTOMERS TO ESTABLISH A REGULAR ACCOUNT AND DESIGN A PORTFOLIO FOR GROWTH AND INCOME THAT WOULD BE SUITABLE BASED ON THEIR RISK TOLERANCES AND OBJECTIVES. WE THEN LOOKED AT OTHER OPTIONS WITHIN THE MUNDER FAMILY. CUSTOMER TOLD ME SHE DID NOT WANT TO MAKE ANY CHANGES UNTILL THE FUND REACHED ITS PRIOR VALUE.
