**Allegations:** 01/00/2009-03/00/2009; CLIENT PURCHASED A METLIFE ANNUITY IN JANUARY 2009. CLIENT CLAIMS SHE WAS NOT APPROPRIATELY ADVISED OF THE COMMISSIONS ASSOCIATED WITH THE PURCHASE. CLIENT ALSO STATES THE FA DID NOT INFORM HER IF SHE MADE A WITHDRAWAL FROM THE ANNUITY THAT "ALL BETS WERE OFF" WITH REGARD TO THE INCOME BENEFITS. CLIENT ALSO ALLEGES THAT A HARTFORD ANNUITY WAS PURCHASED IN JANUARY 2009 WITHOUT HER AUTHORIZATION. CLIENT INDICATES SHE RECEIVED NO DELIVERY RECEIPT OF POLICY FROM HARTFORD THAT WOULD INDICATE THE PURCHASE WAS AUTHORIZED. CLIENT ALSO IS NOT SATISFIED WITH THE PERFORMANCE OF THE INVESTMENTS HELD IN THE ACCOUNT AND THE FA'S ADVICE TO "STAY THE COURSE". CLIENT STATES THE FIRST STEP IN MAKING THIS SITUATION RIGHT IS THE REFUND OF THE FULL PRINCIPAL AMOUNT INVESTED IN BOTH OF THE ANNUITIES. CLIENT ALLEGES AFTER THESE TWO STEPS ARE TAKEN, SHE WILL DETERMINE IF ANYTHING ELSE NEEDS TO BE DONE. CLIENT FURTHER STATES SHE HAS LOST OVER \$100,000.00 IN SPITE OF HER CONTINUOUS ATTEMPTS TO "REDIRECT THE COURSE OF HER INVESTMENTS". FILING REQUIRED.

ACCORDING TO OUR RECORDS, THE HARTFORD CRC ANNUITY WAS PURCHASED ON 1/5/09. ALTHOUGH THE CLIENT HAS CLAIMED THE PURCHASE WAS NOT AUTHORIZED, THE PURCHASE WAS REFLECTED ON THE JANUARY 2009 ACCOUNT STATEMENT. OUR RECORDS REFLECT THE CLIENT SIGNED AN ANNUITY CONTRACT SUMMARY. IN ADDITION, THE CLIENT SIGNED A DELIVERY RECEIPT (ON JANUARY 21, 2009) WHICH EVIDENCES THE CONTRACT WAS DELIVERED. THEREFORE, IT IS OUR OPINION THE ANNUITY WAS PURCHASED WITH THE CLIENT'S KNOWLEDGE AND AUTHORIZATION. ACCORDING TO THE FA, MANY OF HER CLIENTS HAVE BEEN CONCERNED REGARDING MARKET CONDITIONS AND THE IMPACT ON ACCOUNT VALUES. SHE HAS INDICATED SHE HAS SPOKEN WITH THE CLIENT ON NUMEROUS OCCASIONS TO REVIEW HER PORTFOLIO. THE FA HAS FURTHER INDICATED SHE ASSURED THE CLIENT THAT SHE BELIEVED THE CLIENT WAS IN QUALITY INVESTMENTS AND DIVERSIFIED; THEREFORE, SHE ENCOURAGED THE CLIENT TO REMAIN INVESTED. IT IS UNDERSTOOD THE CLIENT WAS EVENTUALLY LEANING TOWARDS LIQUIDATING THE INVESTMENTS HELD IN THE ACCOUNT AND THE FA SUGGESTED THE METLIFE ANNUITY WITH THE LIFETIME INCOME SOLUTION PLUS RIDER. THE FA HAS STATED THE CLIENT WAS INFORMED OF THE COMMISSION (4.5%). ACCORDING TO OUR RECORDS, THE ANNUITY WAS PURCHASED ON JANUARY 5, 2009. OUR RECORDS REFLECT THE CLIENT SIGNED A SWITCH LETTER (ON FEBRUARY 25, 2009) WITH REGARD TO THE PURCHASE. HOWEVER, IT IS UNDERSTOOD THE CLIENT SUBSEQUENTLY MADE THE DECISION TO FREE LOOK THE ANNUITY. BASED ON OUR REVIEW, IT APPEARS THE INVESTMENTS PURCHASED AND/OR HELD IN THE ACCOUNT WERE NOT OUTSIDE THE SCOPE OF THE ACCOUNT OBJECTIVES. FOR ILLUSTRATIVE PURPOSES, WE HAVE ENCLOSED COPIES OF THE DECEMBER 2007 AND DECEMBER 2008 STATEMENTS WHICH REFLECT THE CLIENT'S PORTFOLIO ALLOCATIONS VERSUS THE FIRM'S SUGGESTED ALLOCATIONS. CLAIM DENIED.
