What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations: NEW JERSEY CLIENT CLAIMED THAT HE LEARNED THAT A VARIABLE ANNUITY AND MUTUAL FUNDS ARE NOT APPROPRIATE INVESTMENTS FOR THOSE WHO ARE OVER 80 YEARS OLD. ON OR ABOUT JANUARY 27, 2006 THE CLIENT AND HIS WIFE OPENED A NUMBER OF ACCOUNTS WITH THE FIRM INCLUDING A JOINT ACCOUNT, AN IRA ACCOUNT FOR THE HUSBAND, AN INDIVIDUAL ACCOUNT FOR THE HUSBAND AND AN IRA ANNUITY ACCOUNT FOR THE HUSBAND. THE CLIENT'S WIFE DIED IN 2007. THE CLIENT PURCHASED VARIOUS MUTUAL FUNDS IN THREE OF HIS ACCOUNTS. THE CLIENT ALSO PURCHASED A SUNLIFE FINANCIAL MASTERS FLEXIBLE VARIABLE ANNUITY (THE SUNLIFE ANNUITY) IN HIS IRA ANNUITY ACCOUNT IN AUGUST 2006 AND A RIVERSOURCE LIFE INSURANCE NEW SOLUTIONS EVERGREEN VARIABLE ANNUITY (THE RIVERSOURCE ANNUITY) IN HIS INDIVIDUAL ACCOUNT IN MARCH 2006. THE CLIENT CLAIMED THAT HIS INITIAL INVESTMENTS WITH WACHOVIA TOTALED \$813,858. REALIZED AND/OR UNREALIZED LOSSES ON THE CLIENT'S MUTUAL FUND INVESTMENTS AND ANNUITIES ARE ESTIMATED TO BE OVER \$5,001. THE CLIENT WANTS TO BE REIMBURSED FOR HIS LOSSES.

Broker Statement

THE FIRM DENIED THE COMPLAINT VIA A LETTER TO THE CLIENT DATED JUNE 1, 2009. BASED UPON THE TOTALITY OF THE FIRM'S REVIEW, THE FIRM COULD NOT CONCLUDE THAT THE INVESTMENTS THAT WERE RECOMMENDED TO THE CLIENT BY THE FA WERE INAPPROPRIATE INVESTMENTS FOR THE CLIENT BASED UPON HIS AGE. FURTHER, IT APPEARED THAT THE INVESTMENTS THAT THE FA RECOMMENDED TO THE CLIENT WERE CONSISTENT WITH HIS INVESTMENT OBJECTIVES, HIS RISK TOLERANCE, HIS OVERALL INVESTOR PROFILE, HIS CASH FLOW/INCOME NEEDS, AND HIS RETIREMENT AND ESTATE NEEDS. IT WAS APPARENT THAT THE PERFORMANCE OF THOSE INVESTMENTS WAS NEGATIVELY IMPACTED BY MARKET FORCES THAT WERE BEYOND THE CONTROL OF EITHER THE FIRM OR ITS ASSOCIATES, PARTICULARLY WITH RESPECT TO THE UNPRECEDENTED DECLINES THAT OCCURRED IN THE EQUITY, BOND AND CREDIT MARKETS IN 2008.
