What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

ON 05/17/2013, THE OFFICE OF FINANCIAL REGULATION ENTERED A FINAL ORDER ADOPTING THE STIPULATION AND CONSENT AGREEMENT IN THE MATTER OF CHRISTOPHER MICHAEL BECKS. MR. BECKS NEITHER ADMITTED NOR DENIED THE FINDINGS BUT ACCEPTED AND CONSENTED TO THE ENTRY OF FINDINGS BY THE OFFICE. THE OFFICE FOUND THAT MR. BECKS ENGAGED IN INVESTMENT ADVISORY BUSINESS FROM OFFICES WITHIN THIS STATE WITHOUT THE BENEFIT OF LAWFUL REGISTRATION. MR. BECKS AGREED TO PAY AN ADMINISTRATIVE FINE IN THE AMOUNT OF \$12,000. THE OFFICE AGREED TO APPROVE MR. BECKS' APPLICATION AS AN ASSOCIATED PERSON (RA) WITH CS PLANNING CORP EFFECTIVE 05/17/2013.

FIRM OWNER, CHRISTOPHER BECKS, HAS BEEN CONTINUOUSLY REGISTERED AS AN INVESTMENT ADVISOR REPRESENTATIVE ("IAR") WITH THE STATE OF FLORIDA SINCE 2004 WITH Strategic Financial Consultants. MR. BECKS WAS ALSO AN IAR TO CS PLANNING, CORP., AN SEC REGISTERED ADVISOR ("CSP"). IN 2012, AND PREVIOUSLY UNBEKNOWNST TO MR. BECKS, IT WAS DISCOVERED THAT CSP HAD INADVERTENTLY FAILED TO FILE HIS IAR REGISTRATION APPLICATION IN A TIMELY MANNER WITH THE STATE OF FLORIDA OFFICE OF FINANCIAL REGULATION ("FLORIDA"). CSP IS AND WAS THE ONLY PARTY WITH THE ABILITY TO MAKE THAT FILING. AS A RESULT, FLORIDA ASSERTED THAT BECKS HAD ENGAGED IN BUSINESS AS AN IAR OF CSP PRIOR TO OBTAINING PROPER REGISTRATION. BECKS ENTERED INTO A STIPULATED AGREEMENT WITH FLORIDA AND CSP PAID AN ADMINISTRATIVE FINE ON HIS BEHALF.
