Where did this information come from?

THE PLAINTIFFS, FORMER CLIENTS OF PFM CAPITAL MANAGEMENT, SERVED A COMPLAINT ON OR ABOUT JANUARY 5, 2004 AND ASSERTED A VARIETY OF STATE LAW CLAIMS AGAINST PFM CAPITAL MANAGEMENT AND DANIEL C. HENNING FOR DAMAGES FOR FAILING SUFFICIENTLY TO DIVERSIFY CUSTOMER'S ACCOUNT WITH PFM CAPITAL MANAGEMENT. IN JANUARY 2000, CUSTOMER HAD ESTABLISHED AN INVESTMENT ACCOUNT MANAGED BY PFM CAPITAL MANAGEMENT. THE PLAINTIFFS ASSERTED CLAIMS FOR PROFESSIONAL NEGLIGENCE, BREACH OF FIDUCIARY DUTY, BREACH OF CONTRACT, FRAUD, AND INTENTIONAL INFLICTION OF EMOTIONAL DISTRESS. THE PLAINTIFFS DID NOT ASSERT ANY CLAIMS UNDER THE FEDERAL OR STATE SECURITIES LAWS. THE PLAINTIFFS SOUGHT COMPENSATORY DAMAGES IN EXCESS OF \$10,000. THE DEFENDANTS DENIED THE CLAIMS, AND ASSERTED THAT ANY DECLINE IN THE VALUE OF CUSTOMER'S ACCOUNT WAS CAUSED BY THE DECLINE IN THE STOCK MARKETS GENERALLY, AND THAT ANY DELAY IN SELLING SHARES THE CUSTOMER HAD ACCUMULATED IN HIS EMPLOYER'S STOCK THAT HE HAD TRANSFERRED TO PFM CAPITAL MANAGEMENT WAS A DECISION THAT WAS DISCUSSED WITH AND AGREED TO BY CUSTOMER. THE PARTIES HAVE RECENTLY NEGOTIATED A SETTLEMENT OF THESE CLAIMS, WITH THE SETTLEMENT AMOUNT TO BE PAID TO THE PLAINTIFFS OVER 18 MONTHS.

THE PLAINTIFFS, FORMER CLIENTS OF PFM CAPITAL MANAGEMENT, SERVED A COMPLAINT ON OR ABOUT MARCH 3, 2005 AND HAVE ASSERTED A VARIETY OF STATE LAW CLAIMS AGAINST PFM CAPITAL MANAGEMENT, [THIRD PARTY], AND DANIEL C. HENNING FOR DAMAGES FOR FAILING SUFFICIENTLY TO DIVERSIFY CUSTOMER'S ACCOUNT WITH PFM CAPITAL MANAGEMENT AND FOR INVESTING HER ACCOUNT IN



UNSUITABLE AND RISKY INVESTMENTS. IN FEBRUARY 1998, CUSTOMER HAD ESTABLISHED AN INDIVIDUAL RETIREMENT ACCOUNT MANAGED BY PFM CAPITAL MANAGEMENT. CUSTOMER ESTABLISHED THE ACCOUNT WITH COCA-COLA STOCK. SHE HAS ASSERTED CLAIMS FOR BREACH OF FIDUCIARY DUTY, BREACH OF CONTRACT, NEGLIGENCE, FRAUD, AND INTENTIONAL INFLICTION OF EMOTIONAL DISTRESS. SHE HAS NOT ASSERTED ANY CLAIMS UNDER THE FEDERAL OR STATE SECURITIES LAWS. SHE SEEKS COMPENSATORY DAMAGES IN EXCESS OF \$10,000.
