### What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

### Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Instead, the client was given an annuity with No Guaranteed Period". "Selecting a No Guaranteed Period annuity was not consistent with the client's wishes, and it is an otherwise unsuitable investment, given his circumstances". The beneficiaries of the Estate are seeking adjustment for "funds [the annuity] it would have paid if the client had passed away with a guarantee".

**Product Type:** Annuity-Fixed

**Alleged Damages:** \$0.00

**Alleged Damages Amount Explanation (if amount not exact):** The attorney representing the estate is seeking adjustment for an unstated amount of payments which the beneficiaries would have received had an annuity been selected with a guaranteed minimum payout.
