IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

I deny these allegations in their entirety and maintain they were without merit. The matter was originally filed against my firm for alleged failure to supervise and I was included in the claim. The claim selectively focused on specific investment losses while disregarding aggregate household gains and the clients' actual high-net-worth status. The discovery phase revealed substantial undisclosed assets, including a second home and a luxury vessel. The relationship ended on good terms five years before this claim was raised, about a decade after initial purchase, to which they collected monthly income. Furthermore, I provided uncompensated advisory services for their significant outside assets, including 401ks and stock options, which experienced successful growth. The firm elected to settle for \$14,750 below the reporting threshold solely to avoid protracted litigation during significant personal family obligations. I did not contribute to the settlement, and this remains my only disclosure.
