I STILL STAND FIRM WITH MY OPINION THAT [CUSTOMER] WAS IN NO WAY EVERY MISLED OR MISINFORMED, SHE CHOSE THIS PRODUCT, NOT ME. TO ME, BEING A VALIC FINANCIAL ADVISOR, IT DID NOT MATTER TO ME ONE WAY OR ANOTHER WHAT OPTION SHE CHOSE. I PRESENTED SEVERAL OPTIONS AND MET WITH HER ON MULTIPLE OCCASIONS SPENDING A TOTAL OF SEVERAL HOURS WITH HER AND THE END DECISION WAS HER DECISION TO ROLLOVER HER MONEY INTO THE VALIC PDA. I PRESENTED THE FACTS, SHE SIGNED AND AFTER APPROXIMATELY 18 MONTHS OF BEING EXTREMELY HAPPY IN THE OPTION SHE CHOSE, SHE SPOKE TO A NIECE, WHO IS A FINANCIAL ADVISOR WITH EDWARD JONES AND THE NIECE ADVISED HER THE VALIC PDA WAS NOT A GOOD OPTION FOR HER AND IMMEDIATELY [CUSTOMER] DECIDED SHE SHOULD NOT BE IN THIS PRODUCT ANY LONGER AND TRIED TO HOLD ME ACCOUNTABLE FOR HER ACTIONS.
