**Broker Statement**

Clients purchased two VUL policies in 2013 as part of their comprehensive retirement plan. Subsequently, their business was adversely affected by one spouse's health problems and the COVID pandemic of 2020. Consequently, they stopped making the premium payments necessary to sustain the cash value of the policies. Nonetheless, the policies are still very much in force and provide \$2 million of insurance. So, the allegation that they have wasted \$230,000 is inaccurate.
