### Where did this information come from?

**Broker Statement** IR STATED HE MET WITH CLIENTS APPROXIMATELY EVERY SIX MONTHS TO REVIEW THEIR ACCOUNTS. DURING THESE REVIEWS, IR INDICATED CLIENTS WOULD CONTINUALLY QUESTION THE FLUCTUATION OF INCOME AS WELL AS THE OVERALL PERFORMANCE OF THEIR PORTFOLIO.



FURTHER, IR STATED HE BEGAN DISCUSSING POTENTIAL CHANGES WITH CLIENTS IN OCTOBER 2002. THE PROPOSAL TO INVEST IN THE LORD ABBETT MUTUAL FUNDS WAS MADE DURING A DECEMBER 2002 MEETING AND IR STATED THAT ALL ASPECTS OF THE FUNDS WERE DISCUSSED. IR ALSO STATED THAT HE PROVIDED PROSPECTUSES, LORD ABBETT MARKETING MATERIALS AND AN INVESTOR HANDOUT ON THE BOND. THE CHANGES WERE AGAIN DISCUSSED DURING A JANUARY 2003 MEETING AND IR STATED THE TRADES WERE ENTERED BASED ON CLIENTS' AUTHORIZATION TO PROCEED WITH THE PROPOSED PLAN. CLIENT VISITED WITH IR AFTER THESE TRADES REGARDING THE CASH AVAILABLE IN THE ACCOUNT DUE TO UNEXPECTED EXPENSES. OUR RECORDS REFLECT A CHECK WAS ISSUED ON JANUARY 3, 2003, AS REQUESTED BY CLIENT. ANOTHER MEETING OCCURRED IN FEBRUARY 2003, WHERE IR STATED HE REMINDED CLIENT OF PREVIOUS CONVERSATIONS REGARDING WITHDRAWALS AND IR'S RECOMMENDATION TO REDUCE THE AMOUNT BEING WITHDRAWN UNTIL THE MARKET BEGAN PERFORMING BETTER. IR STATED HE INFORMED CLIENT HE BELIEVED CLIENT WAS IN A BETTER POSITION MOVING FORWARD. ACCORDING TO IR, CLIENT CONTACTED HIM A FEW DAYS LATER AND REQUESTED THE SYSTEMATIC WITHDRAWAL BE INCREASED, WHICH WAS DONE AS REQUESTED. BASED ON OUR REVIEW, IT DOES APPEAR THE CHANGES TO THE PORTFOLIO WERE THE RESULT OF SEVERAL DISCUSSIONS WITH IR AND WERE AUTHORIZED. FURTHER, IT APPEARS COMMISSIONS INVOLVED WITH THE TRANSACTIONS WERE DISCUSSED AND PROVIDED IN THE MUTUAL FUND PROSPECTUSES. CLAIM DENIED
