IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement	In an effort to reduce expenses a proposal was made to liquidate the annuity, and



incorporate a less expensive income strategy. Shortly after the annuity surrender, it was discovered a surrender charge had been applied. The annuity issuer was contacted immediately, and agreed to reinstate the policy, all of which occurred late on a Friday afternoon. Over the weekend, the client received a trade confirmation from the annuity company showing the surrender charge, and sent an email to the financial advisor. The client was contacted promptly Monday morning, with an explanation that the process to reinstate the annuity was initiated Friday afternoon. The firm indemnified the issuer, and agreed to pay any market loss resulting from the period of time from distribution to reinstatement. The client apologized for the email reaction and sent another email requesting the complaint be withdrawn as she did not wish to proceed since the resolution was already in progress when she sent the email.
