**Allegations:** IN APRIL 2000,CUSTOMERS ALLEGE THAT MR. KANAGY RECOMMENDED THEY MOVE THEIR MONEY FROM MUTUAL FUNDS INTO ANNUITIES, WHICH WERE ANNUITIZED. THE CUSTOMERS NOW CLAIM THEY DID NOT UNDERSTAND THEIR ANNUITIES WERE ANNUITIZED AND ARE REQUESTING THAT THEY BE UNANNUITIZED. THE FIRM INVESTIGATED THE CUSTOMERS COMPLAINT AND CONCLUDED IT WAS BASELESS AND WITHOUT MERIT. FIRST, MR. KANAGY PROVIDED THE CUSTOMERS WITH DETAILED INFORMATION REGARDING THEIR ANNUITY CONTRACTS BOTH PRIOR TO AND IMMEDIATELY AFTER THEIR PURCHASES. SECOND, THE ANNUITIES PURCHASED BY THE CUSTOMERS WERE IMMEDIATE ANNUITIES, MEANING THAT THE CUSTOMERS BEGAN RECEIVING PAYMENTS IMMEDIATELY. THIRD, THE CUSTOMERS ACKNOWLEDGED IN WRITING THAT THEY UNDERSTOOD THEIR ANNUITIES COULD NOT BE SURRENDERED ONCE THEIR FREE-LOOK PERIOD ENDED.

**Allegations:** THE CUSTOMER'S ALLEGE THAT THEIR ANNUITY CONTRACT GUARANTEES 3% PER YEAR COMPOUNDED ANNUALLY, SHOULD THE MARKET DECLINE. HOWEVER, THEY STATE THAT THEY WERE RECENTLY INFORMED THAT THEY DO NOT QUALIFY FOR THE 3%. THE CUSTOMER'S FURTHER ALLEGE THAT WHEN PURCHASING TWO ANNUITIES THEY WERE INFORMED THAT THE RATE WAS 7.09% AND THAT THEY UNDERSTOOD THEIR MONEY WAS BEING INVESTED IN "A STABLE FUND OF SOME KIND." THE CUSTOMERS ARE UPSET BECAUSE OF LOSSES THEY HAVE INCURRED.
