What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement
I believe the inexperience of my former employer (who indicated that my client's transfer would be their "guinea pig") created multiple delays over a five-month period on a time-critical transfer request of a \$25 million account that included a substantial collateralized loan. This delay created a possible default situation on the loans and subjected my client to possible seizure and liquidation of his assets because of a securities industry transfer process over which he had no control. The internal email sent was to finalize the last part of the transfer process needed to keep my client from irreparable harm and its contents were factually correct; however, the originator's name was not. Neither the client nor the firm were at risk



from the generic information in the internal email. The client has expressed his gratitude for my assistance in protecting his interests and remains my client to this day.
