What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations:	On December 31, 2023, Stureman's investment advisory registration was terminated due to his failure to renew. Subsequently, the Division twice notified Stureman that he could not continue to transact in investment advisory services until he renewed his registration. However, Stureman continued to transact in investment advisory services until his registration was approved on January 31, 2024, and charged his clients approximately twenty-five-thousand-five-hundred-eighty-four dollars and nine cents (\$25,584.09) for his investment advisory services transacted while not lawfully registered.
