REACHING HER GOALS WITHIN THE ACCOUNT. THE COMPLAINT ALLEGES THAT THESE INSTRUCTIONS WERE REFUSED AND BECAUSE OF THIS THE CLIENT ALLEGES THAT SHE HAS INCURRED LOSSES WITHIN THE ACCOUNT.

AN INQUIRY BY THE COMPLIANCE DEPARTMENT AS WELL AS COUNSEL INVOLVED THE INTERVIEWING OF THE REPRESENTATIVE, ALONG WITH REVIEWING THE INTERVIEW NOTES COMPOSED BY THE REPRESENTATIVE AND OTHER PERSONS IN THE BRANCH OFFICE DURING AND AFTER EACH CONVERSATION WITH A CLIENT. THE BRANCH OFFICE PRACTICE IS TO TAKE NOTES DURING EACH CONVERSATION AND/OR CONTACT, KEEP THE NOTES, AND/OR REDUCE THE NOTES TO WRITING IN A CHRONOLOGICAL SEQUENCE. THE CLIENT MEETING NOTES INDICATED THAT THERE WAS AN ANNUAL REVIEW MEETING IN AUGUST 2007 WITH THE CLIENT, BUT NO MEETING OR CONVERSATION BETWEEN THE CLIENT OR REPRESENTATIVE OR ANYONE ELSE IN THE BRANCH OFFICE IN MAY 2008. AFTER COMPLETING THE REVIEW IT APPEARED THAT THERE WAS INSUFFICIENT BASIS TO DEMONSTRATE THAT THE CLIENT INSTRUCTED THE REPRESENTATIVE TO TRANSFER THE ASSETS IN HER ANNUITY CONTRACT TO ANOTHER INVESTMENT OPTION IN MAY 2008. AS A RESULT THE CLAIM WAS DENIED.
