IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement	I believe there is no merit to the clients allegation. The clients were informed of and had the risks explained to them and understood the risks before investing. They also received detailed information regarding the risks before investing. They incurred a loss due to their untimely sale after only 210 days of holding the investment. Upon opening the account, the clients indicated a moderate risk tolerance and a time horizon of longer than ten years. Further more, the Firm reviewed the complaint and the allegations made and based on that review, determined that there was no validity to the allegations and denied the complaint by letter dated November 10, 2022.
