What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

Since this complaint has been denied and there is no evidence of a written complaint. I request that UBS change their response to "No" for section 14I (3) and the Amended form section 7 A changed to " Yes " and 7 B to "No." In addition , I request the UBS expunge this alleged complaint from my U 4 as there is no evidence of a written complaint. Upon investigation , there is no such evidence of a written complaint from [REDACTED] alleging misrepresentation of fees. Any dissatisfaction expressed by [REDACTED] in the e-mail obtained and dated 2/12/26 to UBS advisors Caitlin Perry and Margo Jones was instigated by these advisors and UBS management in an attempt to slander my good long-standing relationship and reputation with the client attempting to retain the client at UBS as I transitioned to Wells Fargo Advisors. The 2/12/26 email from [REDACTED] is not a written complaint , but a summary and result of an initial conversation between [REDACTED], Caitlin Perry and Margo Jones recapping the conversation of 2/12/26. I was not aware of and deny the comments of dissatisfaction within the email from [REDACTED]. Since I was not provided evidence of a written complaint related to misrepresentation of fees , I ask UBS to retract the allegation listed on my U-4 as it could be construed



as defamation.
