IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

Employing firm when activities occurred which led to the complaint: ALLSTATE FINANCIAL SERVICES, LLC

Allegations: ON SEPTEMBER 26, 2008, CUSTOMER COMPLETED TRANSFER PAPERWORK TO HAVE \$80,000 OF ASSETS IMMEDIATELY LIQUIDATED AND TRANSFERRED FROM HER ALLSTATE FINANCIAL SERVICES, LLC (AFS) BROKERAGE ACCOUNT TO A LINCOLN BENEFIT LIFE FIXED ANNUITY. THE CUSTOMER ALLEGES THAT THE REPRESENTATIVE INDICATED THAT THE TRADE ORDERS TO SELL \$80,000 OF ASSETS WOULD BE PLACED IN HER BROKERAGE ACCOUNT THAT SAME DAY, ON SEPTEMBER 26, 2008. THE REPRESENTATIVE DID NOT PLACE THE TRADES TO LIQUIDATE THE ASSETS UNTIL OCTOBER 10, 2008. BETWEEN SEPTEMBER 26, 2008 AND OCTOBER 10, 2008 THE CUSTOMER EXPERIENCED APPROXIMATELY \$20,000 IN LOSSES IN HER BROKERAGE ACCOUNT AND REQUESTED TO BE REIMBURSED FOR THOSE LOSSES DUE TO THE REPRESENTATIVE'S LACK OF TIMELY EXECUTION OF THE TRADE ORDERS TO SELL.
