What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

 - A "settled" matter generally represents a disposition wherein the parties involved in a dispute reach an agreement to resolve the matter. Please note that Investment Adviser Representatives and firms may choose to settle customer disputes or regulatory matters for business or other reasons.
 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

Broker Statement Allegations: A prior co-Trustee alleges concerns regarding the current Trustee's (a law firm) payment to the advisor for analysis related to the prior Trustee's account activity.

Broker's Comment: The current Trustee (a law firm) paid the advisor for analysis



related to the current Trustee's concerns with the prior Trustee's activity. The payment was for non-financial advice and distributed after the investment account was closed. The advisor did not seek firm permission for the outside business activity, nor did she disclose the outside business payments. The advisor admits to the violation of firm policy. Nonetheless, LPL denies the prior Trustee's demand to reimburse the current Trustee (Trust), as the payment for services was negotiated at arms-length by sophisticated professional parties. Moreover, the current Trustee has not expressed dissatisfaction concerning advisor's service.
