**Broker Statement**

Client wanted to pass money to her grandchildren. All of the purchases of illiquid securities were reviewed by the client, and her tax and legal team. Breakpoints for the large purchases were disclosed and received by the client. Family members questioned the transaction and engaged a new attorney to file a complaint against us. Upon receipt of the complaint, the client's original legal and tax team informed the "new" attorney of the complex time and effort the client had spent setting up the entities and the transactions, the legal reason why it was done, the manner it was done, and finally the manner and secrecy around it. As a result, this claim was denied.
