### What is included in a IAPD report?

### Where did this information come from?

Time frame September 2018-Marich 2019.

**Broker Statement** Firm considers complaint to be wholly baseless and contrived. Representative did not withdraw funds from client's account without authorization or refuse orders. Complaint was initiated after divorce proceedings were filed and the Court entered a mutual restraining order freezing client's assets, including his IRA. Client's IRA was later distributed equally to client and representative upon their mutual consent and Court order. Client withdrew the complaint in writing on 8/27/19.
