### What is included in a IAPD report?

### Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

**Allegations:** The Alabama Insurance Department (the "Department") alleged the registered representative provided misinformation on a license application in violation of Section 27-7-19(2), Code of Alabama 1975. Specifically, in response to question number 3, "Have you EVER had an insurance license denied, suspended or revoked by any insurance department or had a complaint issued against you by an insurance department the registered representative answered "no." After investigation by the Department in order to renew the registered representative's license, it was discovered that the registered representative had his license suspended by the Department on or about October 25, 1999, for non-renewal. Without conceding the violation alleged, but in the interest of bringing the matter to resolution without further proceedings, the registered representative entered into a settlement agreement and order.
