IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement

This report stems from an arbitration claim filed against UBS by several customers-only one of whose accounts I handled-- alleging that over a decade ago the firm performed inadequate due diligence on a fund of funds offered to our clients. It is reported on my record solely because FINRA reporting rules require that it be reported on the record of each of the customers' brokers of record at the time the investments were made. I am not a party to this action, there are no allegations against me, and my name does not even appear anywhere in the complaint. At the time my customer made this investment-over a decade ago-it was approved for sale by UBS. I gave this customer the same consideration and careful advice I have given all of my customers throughout my career.
