What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

FIRM'S COMMENT: \$900,000 SETTLEMENT OF THE CUSTOMER COMPLAINT OCCURRED BETWEEN U.S. BANCORP, AN AFFILIATE OF U.S. BANCORP INVESTMENTS, INC. ("USBI"), AND THE CUSTOMER. U.S. BANCORP AGREED TO PURCHASE THE AUCTION RATE PREFERRED SECURITIES ("ARS") FROM THE CUSTOMER AT A PRICE EQUAL TO THE PAR VALUE PLUS DIVIDENDS OR INTEREST ACCRUED SINCE THE MOST RECENT PAYMENT DATE (AT THE TIME OF THE REPURCHASING). USBI DID NOT REPURCHASE THE ARS FROM THE CUSTOMER NOR DID THE REPRESENTATIVE CONTRIBUTE ANY DOLLAR AMOUNT TO THE SETTLEMENT.
