IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

[CUSTOMER] WORKED WITH MY FATHER FOR POTTSTOWN SCHOOL DISTRICT. THEY WERE BOTH OFFERED A KEY MAN INSURANCE POLICY FROM MASS MUTUAL IN 1987, THEY BOTH ACCEPTED. THE FUNDS THE POTTSTOWN SCHOOL DISTRICT PUT IN WERE TO BE REPAID IN 11 YEARS, BUT THE POLICIES COULD NOT PAY BACK THE SCHOOL DISTRICT WITHOUT CREATING PROBLEMS. WE LOOKED AT THE MANY POSSIBILITIES AND THOUGHT VARITRACK WAS THE BEST OPTION. THE RECOMMENDATION I MADE TO [CUSTOMER] WAS THE SAME AS I MADE TO MY OWN FATHER TO FIX THE PROBLEMS OF MASS MUTUAL. [CUSTOMER] MET WITH MYSELF AND [DISTRICT MANAGER], DISTRICT MANAGER FOR KEY ADVISORS. I BELIEVE [CUSTOMER] MET WITH [DISTRICT MANAGER] TWO OR THREE MORE TIMES, I WAS NOT PRESENT. MULTIPLE ILLUSTRATIONS WERE DONE EXPLAINING THE PRODUCT AND THE RISK INVOLVED. HE WAS ALSO TOLD HE WOULD NEED TO EITHER DECREASE COVERAGE OR ADD TO THE PREMIUM. THIS WAS A MAJOR DISCUSSION. HE WAS WARNED THAT IF HE TOOK THE SCHOOL DISTRICT PORTION OUT AND THE MARKET WENT DOWN HE WOULD HAVE TO ADD MONEY TO KEEP THE POLICY IN FORCE OR DROP COVERAGE AMOUNTS. I MADE NO RECOMMENDATIONS ON ASSET ALLOCATION AND WAS NOT PRESENT WHEN THIS WAS DONE. [CUSTOMER] IS A WELL EDUCATED MAN, HE HAS HIS DOCTORATE AND A BACKGROUND IN MATH. HE HAD MUTUAL FUNDS AND HAD BEEN INVESTING FOR SOME TIME, HE ALSO HAD A PRUDENTIAL



VARIABLE LIFE POLICY AT THE TIME OF APPLICATION FOR \$123,000. I BELIEVE THE REASON [CUSTOMER] IS UNSATISFIED IS THAT HE KNEW THIS WAS GOING TO BE A WORK IN PROGRESS AND I BELIEVE THE PROBLEM CAME ABOUT FROM A LACK OF SERVICE DURING THE 3 YEAR PERIOD AND 2 BEAR MARKETS.
