What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

Allegations:	S-16-1931-17-CO01 On February 16, 2017, the Securities Division entered into a Consent Order with Respondents Creative Money LLC and Melinda Janelle Crary, a.k.a. Mindy Crary. In the Consent Order, the Securities Division alleged that Creative Money and Crary violated the Securities Act by acting as an investment adviser and/or an investment adviser representative while not registered to do so. Without admitting or denying the Securities Division's allegations, Respondent agreed to cease and desist from violations of RCW 21.20.040, the registration provisions of the Securities Act. Respondents Creative Money and Crary agreed to pay a fine of \$10,000 and investigative costs of \$5,000. Respondents Creative Money and Crary waived their right to a hearing and judicial review of the matter.
